

PRINCIPLES OF PERSONAL DATA PROTECTION

Personal Data Processing Information

TECHNiCOAT s.r.o. shall be responsible to protect your personal data. All personal data that you provide us are processed in a transparent and responsible manner in compliance with the Regulation of the European Parliament and of the Council 2016/679. You shall have the right to access your personal data on request and receive information whether your personal data are processed or not. You shall have the right to obtain the rectification or erasure of your personal data if provided based on your consent. In case of automated processing, you shall have the right to data portability and to not be subject to decision solely based on this decision-making. If you have any questions or requests concerning the processing of your personal data, do not hesitate to contact us in writing at the registered address of the company.

Personal Data Security

We shall ensure the security of your personal data that you provide us. We took appropriate technical and organisational actions to protect your data appropriately with a view to the significance of their processing. No unauthorized person may access the personal data collected from you and we shall not transfer your personal data without your consent to any third parties for further processing unless enforced by law.

Right of Access

You shall have the right of access to your personal data and on your request, we shall inform you whether your personal data are processed or not, and to what extent and for what purpose they are processed. This information shall be provided to you free of any cost within 30 days.

Right to Data Portability

You shall have the right to receive the personal data concerning you in a structured, commonly used and machine-readable format. On your request, your personal data can be transmitted to another data controller.

Data Update, Right to Rectification

You shall have the right to obtain the rectification of your personal data held by our company. If you identify that our data are no longer up to date, you shall have the right to obtain the rectification.

Right to Object

You shall have the right to object to processing of your personal data if you suspect that your data are not processed in accordance with the current legislation of the Czech Republic and the European Union. Consequently, we shall investigate whether your request is legitimate.

Right to Restriction of Processing

You shall have the right to obtain restriction of processing if you suspect that our data concerning you are inaccurate, or the processing of your personal data is unlawful, or if you suppose that we no longer need the personal data for the purposes of the processing.

Right to Erasure

You shall have the right to obtain at any time the erasure from our database of your personal data processed based on your explicit consent, and we shall have the obligation to erase your personal data.

Cookie Files

Cookie files are small text files that are not distributed anywhere, these files can be deleted from your browser, or can be fully blocked. Cookies do not collect any personal data, however, we are unable to ensure the full functionality of our website without those files.

Analysis and Statistics

We monitor and analyse our website using analytical service. None of data analysed using this service are your personal data. This service is used to identify the website traffic and geographical data, or information about the browser and the operating system that you use to access our website. All this information is used for marketing purposes and to improve our website and its content as well as for the purposes of legal protection.
